All medical practitioners on the approved list of Directorate General (Ports and Shipping) shall endorse Page-19 of SSB biannually after thorough medical examination and tests as per this office relevant circulars / letters, which have already been uploaded on Mercantile Marine Department Website / URL.

2. In view of above, all Registered Manning Agents are advised that:
 - i. Prior signing-on, SSB of seafarers including Master, may be ensured for medical endorsement by registered medical practitioners.
 - ii. Directives conveyed vide this office letter No.5(11)/98-Sh.II (Vol.II) dated 20th September 2019 to Government Shipping Office, Karachi for endorsement Not Valid for Foreign Flag Vessels on Page No. 19 of SSB has been discontinued with effect from 8th January 2020.
